DECISION

September 30, 2019

I. INTRODUCTION

Executive Express Limo, LLC (Seller) is the holder of Livery Permit No. 2484 last issued by the Department of Transportation (Department) on March 26, 2002, authorizing the operation of five (5) motor vehicles, with a seating capacity of less than ten (10) adults, in General Livery Service between all points in Connecticut from a headquarters in Branford.

II. APPLICANTS' PROPOSAL

By joint application filed on August 20, 2019, and given Docket No. 1908-S-94-L, the applicants seek Department approval of the sale and transfer of the authority granted under Livery Permit No. 2484 from the Seller to LIMO 24/7, LLC who is the sole member of Executive Express Limo, LLC.

III. FINDINGS OF FACT

- 1. The Applicants have submitted the proper application before the Department.
- 2. After a review of the Seller's records, it was determined that all of the vehicles are registered and in use for the six months prior to the filing of the instant application.
- 3. The Buyer is financially able to staff, equip and operate the livery service transferred herein.
- 4. The required Criminal Conviction History Report (CCHR) was filed with the application.
- 5. A copy of the Purchase Agreement was submitted with the application.
- 6. Proof of sufficient insurance coverage for the Buyer was submitted with the application.

IV. CONCLUSION

The Buyer incorporates the new livery service into its existing livery business retaining its current name and livery permit number.

Therefore, based upon the facts stated above, and pursuant to Section 13b-103, the Department hereby approves the sale and transfer of the authority granted under Livery Permit Number 2484, as proposed, to the Transferee and said Permit is amended and reissued in the following form:

LIVERY PERMIT NO. 2484 FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Executive Express Limo, LLC is hereby permitted and authorized, in accordance with and under the provisions of the General Statutes, as amended, to operate five (5) motor vehicles, each having a passenger seating capacity of ten (10) adults or less, in General Livery Service between all points in Connecticut from a headquarters in Branford.

This Permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the Permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this Permit. This Permit is transferrable only with the approval of the Department. Vehicles authorized herein must be registered within thirty (30) days of the date of this Decision.

The authority transferred may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of this final decision. If at any time, during the twenty-four (24) month period, the Applicant enters into a contract for sale and transfer of any of the vehicles authorized under Application 1908-S-94-L, the authority granted herein will be revoked.

A Memorandum of this Permit, bearing the seal of the department, shall be kept conspicuously posted in the motor vehicles operated hereunder.
