INTRODUCTION

By documents filed with the Connecticut Department of Transportation (hereinafter "Department"), Leila, Inc., holder of Certificate Number 1098, pursuant to Application No. 2001-RE-6-T, conducting business as a taxicab service, has re-entitled its authority to Enfield Taxi, LLC. Therefore, Certificate Number 1098 is amended and re-issued as follows:

CERTIFICATE NO. 1098
FOR THE OPERATION OF MOTOR VEHICLES IN TAXICAB SERVICE

Enfield Taxi, LLC is hereby permitted and authorized, in accordance with and under the provisions of the Connecticut General Statutes and Regulations of Connecticut State Agencies, as amended, to operate a total of **Four (4)** motor vehicles in taxicab service as follows:

Three (3) of the Four (4) motor vehicles in taxicab service, within, to and from the towns of Bloomfield, East Hartford, East Windsor, Enfield, Farmington, Granby, Hartford, Manchester, Newington, Rocky Hill, Simsbury, South Windsor, Vernon, West Hartford, Wethersfield, and Windsor to all points in Connecticut.

One (1) of the Four (4) motor vehicle in taxicab service within, to and from the towns of East Windsor, Enfield, Somers and Suffield.

All vehicles must be registered under the new company name within 30 days from the date of this decision.

This certificate shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the certificate holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other State Statutes and/or rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend or revoke this certificate.

This certificate is transferable only with the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicle laws of the State of Connecticut, and with such rules, regulations and orders as this Department may from time to time prescribe.

A memorandum of this certificate bearing the seal of the Department shall be kept conspicuously posted in the motor vehicle operated hereunder.
