

SIGNS

The Manual on Uniform Traffic Control Devices for Streets and Highways (MUTCD) is the Federal Highway Administration's standard for all traffic control devices installed on any street, highway, or bicycle trail open to public travel in accordance with 23 U.S.C. 109(d) and 402(a). Section 2A.05 of the MUTCD Classification of Signs provides the following standard:

Signs shall be defined by their function as follows:

Regulatory signs give notice of traffic laws or regulations.

Warning signs give notice of a situation that might not be readily apparent.

Guide signs show route designations, destinations, directions, distances, services, points of interest, and other geographical, recreational, or cultural information.

Guide Signs

Guide signing and supplemental destination signing produce the challenge for traffic greatest engineers. Supplemental Guide signs can be used to provide information regarding destinations accessible from an interchange, other than places displayed on the standard interchange signing. However, such Supplemental Guide signing can reduce effectiveness of other more important signing because guide possibility of overloading the road user's capacity to receive visual messages and make appropriate decisions.

The Connecticut Tourist Attractions Sign Program is intended to create a predictable and recognizable system to help travelers locate places of interest that will make their experience in Connecticut more enjoyable. The Program is administered by the Department of Transportation. The following types of facilities can be considered for Attractions Signing:

Amusement Parks

Arenas, Stadiums, Convention Centers with a seating capacity of at least 5,000.

Colleges or Universities

Cultural Centers

Facility Tours

Historical Sites or Districts

Museums

Observatories

Recreational Areas

Major Shopping Centers with a minimum of 10 stores and 400,000 square feet or a minimum of 30 stores and 100,000 square feet.

Ski Areas State or National Parks Tourist Information Centers Unique Natural Areas Zoological/Botanical Parks or Aquariums
