New Petroleum Products Gross Earnings Tax Return

Purpose: This Announcement identifies a petroleum products gross earnings tax return that is being replaced by a new return.

Effective Date: Effective upon issuance and applicable to petroleum products gross earnings tax returns for quarterly periods beginning on or after April 1, 2005.

Statutory Authority: Conn. Gen. Stat. §12-602.

New Petroleum Products Gross Earnings Tax Return: For quarterly periods beginning on or after April 1, 2005, persons subject to the petroleum products gross earnings tax who:
