It was recommended that an additional level of detail be added to the report, noting that the decision regarding governance type should be made by the next work group. It was noted that the sustainability of the system's business model will depend largely on the type of governing entity that is decided upon. The importance of choosing the appropriate governance model was also noted as there are examples throughout the country of quality measurement system governance models that have not been sustainable.  Operational Recommendations The list of Operational Recommendations of the Final Report was reviewed by the Design Group members. It was noted that patient consent for the use of such a quality measurement system that captures more than clinical data may be different than consent related to a Health Information Exchange, and that this matter will need to be addressed by the next work group.

It was recommended that the term "clinical quality measurement (CQM)" throughout the Final Report and Recommendations be altered to reflect more data types. It was recommended that "statewide quality measurement system" be used throughout the report, and that a sentence explaining this phrase be added to the report. It was noted that the system must keep the patient at the center, and that the system not be a vehicle for advantage of one stakeholder over another. It was recommended that a sentence be added to the governance recommendations restating the value proposition of improving health and healthcare and keeping the patient as the "north star."
