Dear Ms. Gillette:

On February 25, 2009, the Office of Health Care Access (“OHCA”) received your request on behalf of Community Mental Health Affiliates, Inc. for the relocation of its outpatient behavioral health services currently provided at 92 Vince Street, New Britain, Connecticut, to 26 Russell Street, New Britain, Connecticut.

Please be advised that OHCA has reviewed your request and makes the following findings:

1. Community Mental Health Affiliates, Inc. (“CMHA”) is, is a non-profit facility providing outpatient behavioral health services to adults and families, located at 92 Vine Street, New Britain, Connecticut.
2. CMHA is proposing to relocate its outpatient behavioral health services from 92 Vine Street, New Britain, Connecticut to 26 Russell Street, New Britain, Connecticut. This will allow the facility.
3. CMHA anticipates moving the service by April 1, 2009.
4. The primary service area and target population will not change as a result of the relocation of the outpatient behavioral health services to adult and families.
5. No additional services are proposed and no services will be terminated.
6. The total capital expenditure associated with this relocation is \$2,500.

Based on these findings, OHCA has determined that Certificate of Need approval is not required for you to proceed with the relocation of the services of Community Mental Health Affiliate, Inc., from 92 Vine Street, New Britain, Connecticut, to 26 Russell Street, New Britain, Connecticut. Termination of these services would require CON approval, pursuant to Section 19a-638, C.G.S.
