Dear Mr. Czarkosky:

On April 28, 2009, the Office of Health Care Access ("OHCA") received your Certificate of Need ("CON") Determination request concerning the proposal of Child Guidance Clinic for Central Connecticut, Inc. for the relocation of its services from 117 Lincoln Street in Meriden to 384 Pratt Street in Meriden, Connecticut. OHCA has reviewed the information contained in your CON Determination request letter and makes the following findings:


1. Child Guidance Clinic for Central Connecticut, Inc. ("CGCCC") is a non-profit facility providing outpatient psychiatric treatment for children and substance abuse treatment services at 117 Lincoln Street in Meriden.
2. CGCCC is proposing to relocate its existing licensed services from 117 Lincoln Street in Meriden to 384 Pratt Street in Meriden, Connecticut due to space constraints.
3. The 117 Lincoln Street office of CGCCC is currently licensed as follows:
  - Facility for the Care or Treatment of Substance Abusive or Dependent Persons (DPH), and
  - Outpatient Psychiatric Clinic for Children (DCF).
4. The service area and target population will not change as a result of the relocation of the existing licensed services.
5. No additional programs are proposed and no services will be terminated.
6. The total capital expenditure associated with this relocation is \$900,000.

Based on these findings, OHCA has determined that Certificate of Need approval is not required for Child Guidance Clinic for Central Connecticut, Inc. to proceed with the relocation of its existing licensed services from 117 Lincoln Street in Meriden to 384 Pratt Street in Meriden, Connecticut. Termination of these services would require CON approval, pursuant to Section 19a-638, C.G.S.
