Dear Ms. Bonilla:

On December 17, 2009, the Office of Health Care Access ("OHCA") received your letter regarding the establishment of a primary care clinic at 426 East Street, New Haven, Connecticut. OHCA has reviewed this matter and makes the following findings:

- 1. Chemical Abuse Services Agency, Inc. d/b/a Multicultural Ambulatory Addiction Services ("MAAS") is a non-profit facility providing outpatient psychiatric treatment and substance abuse services for adults at 426 East Street, New Haven, Connecticut.
- 2. MAAS is proposing to include the provision of Primary Care to its clients at 426 East Street, New Haven, Connecticut.
- 3. MAAS is currently licensed as a Substance Abuse Treatment Facility and as a Psychiatric Outpatient Facility. The services currently provided are outpatient treatment, chemical maintenance (methadone), ambulatory detoxification and day treatment.
- 4. MAAS plans to provide physical exams, health promotion, disease prevention, health maintenance, counseling, patient education, evaluation, diagnosis and treatment of acute and chronic illnesses.
- 5. The proposed services will be provided to the current population which includes innercity traditionally under-served Latino and African American men and women.
- 6. There is no capital expenditure associated with this proposal.

Based on the above findings, OHCA has determined that Chemical Abuse Services Agency, Inc. d/b/a Multicultural Ambulatory Addiction Services is a health-care facility and that the request to establish a primary care clinic at 426 East Street, New Haven, Connecticut represents the establishment of a new service for a health care facility or institution. Therefore, the proposal of Chemical Abuse Services Agency, Inc. d/b/a Multicultural Ambulatory Addiction Services to establish a primary care clinic in New Haven requires Certificate of Need authorization by OHCA pursuant to Section 19a-638(a) (2) of the Connecticut General Statutes.
