Dear Ms. Duzan:

On April 29, 2013, the Office of Health Care Access ("OHCA") received your Certificate of Need ("CON") determination request on behalf of Kids Dental Care, LLC ("Applicant") with respect to whether a CON is required for the Applicant to become licensed as an outpatient surgery center and provide general anesthesia to the pediatric population at an office located in Bristol, CT.

The Applicant is a for-profit entity currently providing routine and complicated dental care under the license of board certified and board eligible dentists. Kids Dental Care, LLC seeks approval through the Department of Public Health to be licensed as an outpatient surgical center. In addition, the Applicant seeks to have a licensed Anesthesiologist on site to provide anesthesia care ranging from minimal/conscious sedation up to general anesthesia to assist with safe and comfortable care of pediatric patients.

Pursuant to Connecticut General Statutes § 19a-638(a)(5), a CON is required for the establishment of an outpatient surgical facility, as defined by § 19a-493b. Although §19a-493b(d) provides an exception to the outpatient surgical facility CON requirement for persons licensed to practice dentistry, the Applicant is seeking licensing as an outpatient surgical facility providing anesthesia, which does require CON authorization. Based on the aforementioned, the Applicant is not subject to the exemption provided by § 19a-493b(d) and is thus required to obtain CON authorization in order to establish an outpatient surgical facility. 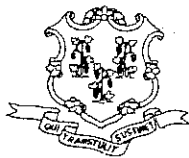
