CVR is a private physician radiology practice that has provided x-ray, MRI, CT, fluoroscopy, mammography, ultrasound and bone densitometry services in the Greater Hartford area for more than 40 years. CVR currently owns and operates two CT scanners and two MRI scanners (the "Imaging Equipment"). CVR is not a health care facility or institution and thus is not licensed by the Connecticut Department of Public Health.

Due to events occurring in the health care industry and as part of its efforts to ensure continuity of care, CVR proposes a restructuring of its practice that includes the transfer of its Imaging Equipment to a new wholly-owned subsidiary of CVR, referred to herein as "NewCo." As a wholly-owned subsidiary, NewCo would initially be indirectly owned solely by CVR's existing owners (Drs. Staehle and Gomez). Thereafter, Drs. Staehle and Gomez plan to admit additional physician members, or entities owned solely by physicians, to NewCo. NewCo will remain the owner of the Imaging Equipment. New members of NewCo will not acquire the Imaging Equipment or other assets of NewCo by purchase, lease, donation or other comparable arrangement.

Regs. Conn. State Agencies § 19a-630-1(1). The internal restructuring to move the Imaging Equipment to a wholly owned subsidiary of CVR is not an acquisition. It is simply an intercompany arrangement where existing imaging equipment is transferred to an affiliated entity. Such transfers occur regularly in the industry and have never required CON approval. This analysis is consistent with OHCA's recent determination that Housatonic Valley Radiological Associates, P.C. ("HVRA PC") was not required to seek CON approval to transfer its MRI and CT scanners to two wholly owned subsidiaries. See OHCA Docket No. 14-31970-DTR.

Further, the subsequent acquisition of membership interests in NewCo will not result in the acquisition of the Imaging Equipment. The new physician members, or entity members owned solely by physicians, will not acquire any of the Imaging Equipment by purchase, transfer, lease, donation or comparable arrangement. Exclusive ownership of the Imaging Equipment will remain with NewCo and will not change after additional physician, or physician entity, members are admitted to NewCo. Per the Connecticut Limited Liability Company Act, no member has any specific interest in property transferred to or otherwise acquired by a limited liability company. Conn. Gen. Stat. § 33-647. Such members have only the right to participate in the company's profits and losses.

In addition, Conn. Gen. Stat. §19a-638(a)(2) requires a CON for transfers of ownership in health care facilities. However, neither CVRG nor Newco is a "health care facility" as that term is defined in Conn. Gen. Stat. § 19a-630(11). Accordingly, the acquisition of an ownership interest in NewCo is not a transfer of ownership requiring a CON. It is also important to note that neither the transfer of Imaging Equipment to NewCo nor the subsequent addition of new

In Docket No. 15-31993-DTR, the Farmington Imaging Center, LLC was not required to seek a CON with respect to its proposed sale of membership interests. In Docket No. 14-31970-DTR (also mentioned above), HVRA of Danbury, LLC and HVRA of New Milford, LLC were not required to seek a CON with respect to the admission of new members in those organizations. Finally, in OHCA Docket No. 15-31997-DTR, Medical Specialty Group, P.C. ("MSG"), an entity owning MRI and CT scanners, sought a determination regarding whether a CON was required in connection with the sale of shares of stock in MSG to other physicians. 

On June 19, 2015, the Office of Health Care Access ("OHCA") received your Certificate of Need ("CON") Determination request on behalf of Connecticut Valley Radiology, P.C. ("Petitioner") with respect to the transfer of imaging equipment to a wholly owned subsidiary.

The Petitioner is a private physician radiology practice that provides x-ray, MRI, CT, Flouroscopy, mammography, ultrasound and bone densitometry services in the Greater Hartford area. The Petitioner currently owns and operates two CT scanners and two MRI scanners (the "Imaging Equipment"). The Petitioner seeks to restructure its practice and transfer ownership of the Imaging Equipment to a new wholly-owned subsidiary ("NewCo") via a tax-free exchange. NewCo will initially be indirectly owned soley by the Petitioner's existing owners, Drs. Staehle and Gomez. Thereafter, NewCo will admit additional physician members. NewCo will continue to own the Imaging Equipment after the new physician members are added.

Pursuant to Connecticut General Statutes § 19a-638(a)(2), a CON is required for the transfer of ownership of a health care facility. However, the Petitioner does not, and NewCo will not, meet the definition of a health care facility as specified in Connecticut General Statutes § 19a-630(10). Therefore, *no CON is required* for the addition of new physician members.

Pursuant to Connecticut General Statutes § 19a-638(a)(10), a CON is required for the acquisition of an MRI or CT. The Petitioner currently owns the Imaging Equipment. Subsequent to the restructuring, NewCo will own the Imaging Equipment. Consequently, the Petitioner is relinquishing ownership of the Imaging Equipment and NewCo is acquiring ownership of the Imaging Equipment. Therefore, a *CON is required* for the Petitioner's proposal regarding the Imaging Equipment, regardless of the addition of new physician members.
