### 2011-12 Annual Identification of Students without Health Insurance

In May 2008, the Connecticut State Department of Education, in collaboration with the Department of Social Services, requested that school districts establish a systematic approach to identify students who lack health insurance and develop a system to consistently provide families of students identified as lacking health insurance with HUSKY information. This ongoing effort fulfills Section 10-206c of the Connecticut General Statutes' requirement that local school districts identify children who lack health insurance and provide information to their parents about the HUSKY plan. This memo serves as a reminder to school districts of the mandate to annually identify students without health insurance.

Approaches to identifying students who lack health insurance include capturing information from:

- the required health assessment form for students entering school and again in 6th or 7th grade and 9th or 10th grade; and
- the annual emergency contact forms for all students enrolled in your district.

In addition to these approaches, your individual school district may have other systems in place, such as parent liaisons, school -based health centers and family resource centers that may be critical partners in providing families with HUSKY information.

### Ordering School Health Records for 2012-13

Attention School Nurse Supervisors:

It is time to order Cumulative Health Records (CHR-I) and Health Assessment Records (HAR-3) for delivery in May and use in the 2012-13 school year. Each district must determine the number of CHR-I and HAR-3 forms needed based on its student population and number of forms currently in stock. Please order sufficient numbers to share with charter, private and parochial schools served by your district and with all health care provider offices in your community. The Connecticut State Department of Education (CSDE) only distributes CHR-I and HAR-3 forms to public school districts. You are responsible for providing the health care providers in your community with forms.

Please complete the order form below for your district and return it to Glenda Stuckey **before March 1, 2012.** We do not stock an excess of extra forms at the CSDE, therefore please order enough to cover your needs for one year. **Please remember your district needs to share its supply with appropriate medical practitioners and other schools in its community.** Orders will be sent to the school district by the end of May 2012.

### Guidelines for the Sexual Health Education Component of Comprehensive Health Education

Today's students are faced with a myriad of health and mental health issues, such as unplanned teen pregnancy, suicide, depression, asthma and obesity. These health issues impede academic outcomes. Research consistently concludes that student health status and student achievement are directly connected, and that student health is one of the most significant influences on learning and achievement. Therefore, it is imperative for health education to be a prominent program of study within Connecticut schools, as outlined in Connecticut General Statutes Sections 10-16b, 10-16c, 10-19(a) and 10-19(b). Sexual health education is one vital component of a planned, ongoing and systematic health education program. These planned health programs provide an opportunity for students to receive information that promotes their health and well-being.

To help districts address sexual health education, the State Board of Education directed the Connecticut State Department of Education (CSDE) to develop a resource guide. The **Guidelines for the Sexual Health Education Component of Comprehensive Health Education (CT Guidelines)** is a companion document to the Healthy & Balanced Living Curriculum Framework and provides guidance to school districts when developing policies, programs, curriculum and instruction in sexual health education.

The **CT Guidelines** are based on the National Health Education Standards, the National Sexuality Education Standards, and supported by several state-level documents including the Department of Public Health's Adolescent Health State Strategic Plan and the CSDE's Guidelines for a Coordinated Approach to School Health.
