## 2009 School Health Survey

The Connecticut State Department of Education (CSDE) would again like to request your participation in the School Health Services Information Survey. In 2007—2008, participation rate was 73 percent. The Connecticut State Department of Education's goal is 100 percent participation. This survey represents an opportunity to continue documenting the school health services provided to students and staff in Connecticut public and private, non-profit schools. Data collection for the 2008-2009 academic year should be conducted during **March and April, 2009**. All surveys **MUST** be completed by **June 6, 2009** to allow adequate time for data analysis.

### **The 2009 Connecticut Health Disparities Report**

Compares leading indicators of health status for racial or ethnic minority populations (and other disparity populations) relative to the White (majority) population of Connecticut. These analyses are presented in the context of current social and economic conditions affecting health outcomes. Health access and health care workforce issues are also addressed. This report will be helpful to policy makers, researchers, health professionals, advocates, and others working to improve the health of all people in Connecticut.

### **Prescription Drug Abuse on the Rise**

#### **University of Connecticut Health Center Webcast**

FARMINGTON, CONN. – Most of us take prescription drugs only for the reason the doctor intended. Nevertheless, an estimated 48 million people (aged 12 and older), according to the National Institute on Drug Abuse, have used prescription drugs for nonmedical reasons in their lifetime. That figure represents approximately 20 percent of the U.S. population.

In recent years, there has been a dramatic increase in prescription drug misuse or abuse. This increase has led to a corresponding increase in ER visits because of accidental overdoses as well as admissions to drug treatment programs for drug addictions.
