## **Medication Administration Regulations**

The regulations for the Administration of Medications by School Personnel and Administration of Medication During Before— and After-School Programs and School Readiness Programs were approved by the Regulations Review Committee on September 28, 2010.

The revised regulations will become effective upon filing with the Secretary of State, which will occur within 14 days of formal notification of approval.

A copy of the regulations will be forwarded to all school nurse supervisors, medical advisors and district leaders when they become effective. Technical assistance and scheduled workshops will also be provided to school districts regarding changes in the regulations.

Additional information will be provided at the School Nurse Supervisor Conference on November 15, 2010.
