### Connecticut Part B FFY 2011 Compliance Data Summary Notes

INDICATOR 4B: The State reported its definition of “significant discrepancy.”

The State reported that 16 districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

For FFY 2011, the State reported that it reviewed the districts’ policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the districts identified with significant discrepancies. The State did not identify any noncompliance through this review.

The State reported that 21 of 170 districts did not meet the State-established minimum “n” size requirement of a minimum of five students with disabilities in the district suspended/expelled for greater than ten days or a minimum of ten students with disabilities in the district in each race category, and were excluded from the calculation.

INDICATOR 9: The State reported that three districts were identified with disproportionate representation of racial and ethnic groups in special education and related services. The State also reported that no districts were identified with disproportionate representation of racial and ethnic groups in special education and related services that was the result of inappropriate identification.

The State provided its definition of “disproportionate representation.”

The State reported that it does not use a minimum “n” size requirement.
