FINAL DECISION AND ORDER

ISSUES:

1. Did the Board of Education offer the Student a free appropriate public education for the 2015/2016 School Year?
2. If not, is the Easton Country Day School appropriate?
3. If the Board of Education did not offer the Student a free appropriate public education and the Easton Country Day School is appropriate, is the Student entitled to reimbursement of the expenses of the Easton Country Day School placement, including speech and social skills services and/or placement at Easton Country School?
4. If the Board of Education did not offer the Student a free appropriate public education but the Easton Country Day School is not appropriate, is the Student entitled to compensatory education services?

PROCEDURAL HISTORY:

The Student requested a special education due process hearing in the above-captioned matter on February 18, 2016. This Impartial Hearing Officer was appointed to hear the case on February 23, 2016. A telephonic pre-hearing conference was convened on April 5, 2016. Attorney Jennifer Laviano appeared on behalf of the Student and Attorney Marsha Moses appeared on behalf of the Board of Education. The deadline for filing the final decision was established to be May 3, 2016. An evidentiary hearing was scheduled for June 17, 2016.

On April 11, 2016 the Student submitted a written request for a thirty-day postponement and extension of the timelines to conduct the hearing and to file the final decision in this case to June 2, 2016. The purpose of the requested postponement and extension was to allow the parties an opportunity to mediate. The Board of Education agreed to the requested postponement and it was granted.

On May 30, 2016, the Student reported that the parties' mediation was scheduled for June 1, 2016 and submitted a second written request for a thirty-day postponement and extension of the timelines to conduct the hearing and to file the final decision in this case to July 1, 2016. The purpose of the requested postponement and extension was to allow the parties an opportunity to pursue due process. The Board of Education did not object to the requested postponement and extension and it was granted.

On June 1, 2016, the Student reported that the parties' mediation was successful and that the parties reached a tentative agreement for resolution of the case. The Student requested that the hearing scheduled for June 17, 2016 be postponed and that the timelines to conduct the hearing and to file the final decision in this be extended for an additional 30 days to allow the parties to pursue due process should the settlement fail. The Board of Education joined in the request and it was granted.

On July 20, 2016, the Student reported that the parties had reached a resolution of the dispute and requested that the matter be dismissed with prejudice.

FINAL DECISION AND ORDER:

It is ordered that the Student's request for dismissal is granted and this matter is dismissed with prejudice.

If the local or regional board of education or the unified school district responsible for providing special education for the student requiring special education does not take action on the findings or prescription of the hearing officer within fifteen days after receipt thereof, the State Board of Education shall take appropriate action to enforce the findings or prescription of the hearing officer.

Appeals from the hearing decision of the hearing officer may be made to state or federal court by either party in accordance with the provisions of Section 4-183, Connecticut General Statutes, and Title 20, United States Code 1415(i)(2)(A).
