TO THE TOWN CLERK:

June 24, 2014

Section 9-433 of the Connecticut General Statutes requires the Secretary of the State to notify the Town Clerk of each town in the state or appropriate district of each primary to be held for state or district ("multi-town") office.

The statute provides further that, "The clerk of each such town shall thereupon cause such notice to be published forthwith in a newspaper having a general circulation in such town, together with a statement of the date upon which the primary is to be held, the hours during which the polls shall be open and the location of the polls."

We are therefore enclosing a NOTICE OF REPUBLICAN AND DEMOCRATIC PRIMARY for the parties and the state and multi-town district offices indicated therein, as well as a suggested form of the statement concerning the date, polling hours and location of the polls for the primary. Not all district offices that are listed on the Notice of Primary apply to your town. Merely select the district office(s) and candidates that do apply before preparing your statements to be published and ballots to be printed. Also, before publishing the enclosed statements, you must add any primary(ies) for municipal office that you may be having, as determined by your registrar of voters, and complete the statement by filling in the location of the polling places.

However, if are having multiple primaries for the same party, you may (if desired) publish one consolidated notice for that party, listing each endorsed and each non-endorsed candidate for each multi-town office, and single-town office, if applicable, following exactly the format of the enclosed notices and listing the offices in the order listed in CGS §9-251. However, separate notices must be published for each party.

Under §9-435 you will receive notice of any primary for municipal ("single-town") office in your town from the party's local Registrar of Voters. Again, in the case of primaries for different municipal offices within the same party, a consolidated notice may be published if desired; but municipal-office primary notices for different parties must be published separately.

PLEASE NOTE: In preparing absentee ballots, polling place ballots and sample ballots, please remember that the order of offices is as listed in CGS §9-251. Also note that candidates' names are to be printed exactly as they appear, and in the order in which they are listed, in the enclosed notices for multi-town district office. (The "ballot versions" of the names are as legally authorized on candidate filings with this office.) The name of the party-endorsed candidate (if any) for each office is to be designated by an asterisk (*) on the ballots. If there is no party-endorsed candidate, the words "No Party Endorsement" shall appear immediately beneath the office designation at the head of the appropriate vertical office column.
