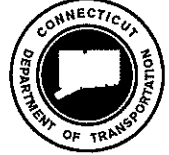

I. INTRODUCTION

Campion Ambulance Service, Inc. (hereinafter “transferor”), is the holder of Livery Permit No. 2304, last issued by the Department of Transportation (hereinafter “Department”) on November 16, 1998, authorizing the operation of

1. Eleven (11) motor vehicles to transport handicapped and elderly persons on regular and irregular routes to service their special needs from a headquarters in Waterbury. Elderly and handicapped shall be defined by those State agencies having jurisdiction over these people.

2. One (1) motor vehicle in general livery service between all points in Connecticut, from a headquarters in Waterbury.

3. One (1) motor vehicle in general livery service between all points in Connecticut, from a headquarters in Torrington.

4. Two (2) motor vehicles for the provision of livery service under contract (s) with or lower tier contract(s) for federal, state or municipal agencies from a headquarters in Waterbury.

5. Three (3) motor vehicles for the provision of livery service under contract(s) with or lower tier contract(s) for federal, state or municipal agencies from a headquarters in Torrington.

II. APPLICANTS' PROPOSAL

By joint application filed on August 28, 2019 and given Application No. 1908-S-100-L, the applicants seek Department approval of the sale and transfer of the authority granted under Livery Permit No. 2304 from the transferor to Trinity Health of New England Emergency Medical Services, Inc. (hereinafter “transferee”).

III. FINDINGS OF FACT

1. The applicants have submitted the proper application before the Department.

2. After a review of the transferor’s records, it was determined that fourteen (14) of the eighteen (18) authorized vehicles are registered. The four (4) unregistered vehicles consist of two (2) governmental livery vehicles in the Waterbury headquarters and two (2) governmental livery vehicles in the Torrington headquarters. **These four (4) vehicles are not compliant with livery regulations and therefore shall not be included in the sale and will be automatically revoked at time of sale.**

3. The transferee is financially able to staff, equip and operate the livery service transferred herein.

4. The required Criminal Conviction History Report (CCHR) was filed with the application.

5. The Purchase Agreement was submitted with the application.

6. Proof of sufficient insurance coverage for the transferee was submitted with the application.

IV. CONCLUSION

The transferee retains its current name and takes on the transferor’s livery permit number and authority.

Therefore, based upon the facts stated above, and pursuant to section 13b-103, the Department hereby approves the sale and transfer of the authority granted under the transferor’s livery permit as proposed, to the

transferee. Following the approval of this sale and transfer, Campion Ambulance Service, Inc. will retain no rights to the authority transferred and Livery Permit Number 2304 is hereby amended and reissued in the following form:

LIVERY PERMIT NO. 2304
FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Trinity Health of New England Emergency Medical Services, Inc. is hereby permitted and authorized, in accordance with and under the provisions of the Connecticut General Statutes, as amended, to operate

1. Eleven (11) motor vehicles to transport handicapped and elderly persons on regular and irregular routes to service their special needs from a headquarters in Waterbury. Elderly and handicapped shall be defined by those State agencies having jurisdiction over these people.

2. One (1) motor vehicle in general livery service between all points in Connecticut, from a headquarters in Waterbury.

3. One (1) motor vehicle in general livery service between all points in Connecticut, from a headquarters in Torrington.

5. One (1) motor vehicles for the provision of livery service under contract(s) with or lower tier contract(s) for federal, state or municipal agencies from a headquarters in Torrington.

The authorization in this decision for livery service under contract(s) with or lower tier contract(s) for federal, state or municipal agencies shall be durational in nature and shall exist only for the period of time that the permit holder has continuing contracts in effect.

This permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within sixty (60) days of the date of this decision.**


The authority transferred may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of this final decision. If at any time during the twenty-four (24) month period the applicant enters into a contract for sale and transfer of any of the vehicles authorized under Application No. 1908-S-100-L, the authority granted herein will be revoked.

This permit is transferable only with the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicle laws of the State of Connecticut, and with such rules, regulations and orders as this Department may from time to time prescribe.

A memorandum of this permit, bearing the seal of the Department, shall be kept conspicuously posted in the motor vehicles operated hereunder.
