I. APPLICANT'S PROPOSAL

By application 1910--TH-110-L) filed on October 3, 2019, pursuant to Section 13b-103 of the Connecticut General Statutes (CGS), (Company Name) (hereinafter "applicant"), holder of Livery Permit Number 3580, seeks authorization from the Connecticut Department of Transportation (hereinafter "Department"), to transfer its Hamden headquarters to Milford, and close the Hamden headquarters. Specifically, to transfer:

1. Four (4) motor vehicles with a passenger capacity of ten (10) passengers or less in general livery service.

II. DEPARTMENT ANALYSIS

A legal notice was mailed to registered livery companies in the headquarters town and towns contiguous to its headquarters town and was not opposed within the thirty (30) days as allowed by statute. The Department's staff has analyzed the evidence presented in this instant application and finds that it should be granted without a hearing.

III. FINDINGS OF FACT

1. The applicant has submitted the proper application before the Department.
2. The Department finds that the applicant's records indicate all its vehicles have been in use and are available for transfer.
3. No opposition was filed by existing operators in the headquarters town.

IV. CONCLUSION AND ORDER

Based on the above and pursuant to Section 13b-103, the instant application, given Application Number 1910-TH-110-L, filed by Seven Star Livery, LLC, is approved and Livery Permit Number 3580 is amended and reissued as follows:

LIVERY PERMIT NUMBER 3580 **FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**


Seven Star Livery, LLC is hereby permitted to operate four (4) motor vehicles with a passenger seating capacity of ten (10) adults or less in general livery service to all points in Connecticut from a headquarters in Milford.

This permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department.

A memorandum of the permit bearing the seal of the Department shall be kept conspicuously posted in the motor vehicles operated hereunder.
